Fuel crunch means icebreaking all winter

Coast Guard will keep channel open from lake to Green Bay

REEN BAY - A broken gasoline pipeline could cut into on-ice recreational options in the bay of Green Bay this winter.

U.S. Venture Inc. has asked the U.S. Coast Guard to keep a 75- to 125-foot-wide navigable channel open from Lake Michigan to the Port of Green Bay through the end of January to ensure that the Kimberly-based company can continue to deliver gasoline and other petroleum products to the region.

The continued closure of the West Shore Pipe Line, which supplied gasoline to northeastern Wisconsin and the Upper Peninsula of Michigan from Milwaukee, means U.S. Venture needs a channel to ensure ship access to its Green Bay
